GENERAL INFORMATION

What is the study plan?

In Italy, university degrees have legal value. This means that universities confer qualifications determined by the educational system. The study plan is the pathway that includes all the academic activities that a student must complete in accordance with the objectives established by the Ministry of Universities and Research (MUR) and by the educational regulations of the degree program. Therefore, it is not sufficient to achieve 180 ECTS for the University of Milan to admit the student to the discussion of the final thesis and, consequently, to award the degree, if those credits are not distributed as indicated in the study plan contained in the program's educational regulations.

Where can I find all the information about study plans?

All information can be found on the degree program's website, in the "Study" section, on the page dedicated to the submission of the study plan: <https://filosofia.cdl.unimi.it/en/study/study-plan-submission>

What is the study plan tutor committee, and what are its functions?

The study plan tutor committee is responsible for guiding students and evaluating all requests of an academic nature. The committee does not deal with general administrative issues or technical problems related to the Unimia platform; for such matters, students must contact InformaStudenti. The committee provides a binding opinion on the adequacy of individual study plans (see below), and the Academic Board has full authority to reject proposals deemed academically inappropriate or lacking sufficient scientific justification.

Members of the study plan tutor committee meet with students (by email or during office hours) according to an alphabetical division by surname. The members of the study plan tutor committee are listed in the "Tutor" section of the "Contact persons" page (section "Programme") on the Philosophy degree program website. The study plan contacts are **Prof. Anna Caterina Dalmasso** (surnames A–L) and **Prof. Diana Di Segni** (surnames M–Z).

When should I contact the study plan tutors?

It is recommended to carefully read this guide first. If there are questions not answered here, you may contact the tutors with **specific** and **clearly formulated** queries.

WHEN AND HOW TO COMPLETE OR MODIFY THE STUDY PLAN

When is the study plan completed?

The study plan is completed at the beginning of the second year. Therefore, it includes both the exams already taken and those that the student intends to take in the second and third years.

When does the window for submission and modification of the study plan open?

For the academic year 2025/26, the submission and modification window for the study plan is open from **September 16 to October 10, 2025**.

How is the study plan submitted?

The study plan must be submitted online through your Unimia personal page.

Can the study plan be submitted at another time of the year?

No, it is not possible to submit the study plan outside this window. The only exception applies to Erasmus students who would otherwise be unable to have their ECTS credits earned abroad recognized.

If I change my mind about the exams I want to take, can I change my study plan?

Certainly. Each year, during September and October, a new submission window opens for the compilation and modification of the study plan. The opening and closing dates of the window are published each year at: <https://www.unimi.it/en/study/bachelor-and-master-study/following-your-programme-study/plan-study>

During this period, a new study plan can be submitted to replace the previous one.

If I decide to take an exam that I did not include in my study plan, must I wait for the next submission window to take it?

According to regulations, yes. Technically, it is possible to take the exam as an extra-plan exam, but this is strongly **discouraged**. If the exam does not comply with the rules of the study plan, it cannot be inserted into your plan, and the credits will remain as extra-plan credits, that is, beyond the required 180 ECTS.

What criterion should I follow to modify the study plan?

An exam can be modified by replacing it with another belonging to the same rule. It is not possible to replace exams belonging to different rules.

I want to graduate by April. Can I complete the study plan without enrolling in the new academic year?

No, only students enrolled in the current academic year can complete the study plan. If you wish to change your plan, you must enroll in the new academic year.

To modify the study plan, must I enroll for the entire next year or only for one semester?

It is not possible to enroll for only one semester; enrollment is always for the entire year, even though tuition fees are divided into two payments.

Is it true that the study plan can be modified outside the window by paying a fee?

It is possible to submit a request to the Rector to modify the study plan outside the regular submission window. Such a request may be submitted before graduation if there are discrepancies between the exams actually taken and those listed in the approved study plan. Submitting this request entails paying a fine for noncompliance with the original plan. Moreover, the request may be accepted or rejected; therefore, this procedure does not guarantee modification of the plan. For these reasons, we advise **against** this solution. Students intending to graduate during the academic year are encouraged to review their study plan and, if necessary, make changes during the modification window at the beginning of the third year.

How can I submit a request to the Rector to modify my study plan?

The request must be submitted via InformaStudenti. The study plan committee, the study plan tutors, and the Academic Board are not responsible for these requests, which are managed by the Rector's Office. Therefore, the study plan tutors cannot provide information about the outcome of the request or whether it will be accepted or rejected.

I am a working student enrolled part-time. Must I submit the study plan by the second year?

Yes, even part-time students must submit their study plan during the same window by their second year.

I forgot to submit my study plan within the official window. What should I do?

If the study plan was not submitted within the established deadlines, a statutory plan will be automatically assigned. The plan can be viewed on the "Study" / "Study Plan submission" page: <https://filosofia.cdl.unimi.it/en/study/study-plan-submission>

I made an error while compiling the study plan and did not follow the rules. What should I do?

If a study plan does not comply with the construction rules, a statutory plan will automatically be assigned.

What happens if I make a mistake while compiling the study plan and include a course that is no longer active without having taken it?

Inactive courses can only be entered if they have already been completed. Otherwise, unless there is a correspondence (see below), a statutory plan will automatically be assigned. In place of the incorrect course, another one from the statutory plan will be inserted, selected in a specific order. If an inactive course is inserted in a rule, the first available unsatisfied exam from the same rule in the statutory plan will be assigned.

What is the statutory plan?

The statutory plan is a plan automatically assigned when the study plan has not been submitted at the beginning of the second year or when the construction rules of the study plan have not been respected. What is the purpose of the statutory plan?

Since it is not possible to register for exams beyond the first year without submitting a study plan, the statutory plan allows students to continue their studies without interruption.

I have been assigned a statutory plan. Can I modify it?

Yes, the plan can be modified during the next opening window for submission and modification of study plans.

HOW TO COMPLETE THE STUDY PLAN

Which exams can be included in the study plan?

Students must strictly adhere to the educational plan outlined in the educational regulations corresponding to their year of enrollment, which can also be viewed on the website in the section dedicated to the study plan: <https://filosofia.cdl.unimi.it/en/courses/educational-plan>

How do I know which study plan I have to follow?

The study plan depends on the year of enrollment. To view your study plan, you will need to select: "Philosophy (Class L-5) – enrolled from academic year 2014/2015 up to academic year 2020/2021."

Wouldn't it be easier to check Ariel to see which courses I can choose?

No. Unfortunately, Ariel is not always up to date and includes deactivated courses. The study plans activated each year and the official course programs can be found on the degree course website: <https://filosofia.cdl.unimi.it/en/courses/course-list-z>

How do I understand the rules of the study plan?

The study plan is divided into rules consisting of a certain number of exams. Each rule is preceded by an indication specifying the number of ECTS to be earned and the number of courses through which to earn them. For example:

This rule means that the student must earn 36 ECTS in this group, through four distinct courses, i.e., four exams worth 9 ECTS each ($9 \times 4 = 36$). Any combination of 9-ECTS exams that meets the total of 36 ECTS and four courses is acceptable.

How do I know if my study plan is correct from an academic point of view? How can I be sure I don't have gaps in my preparation?

The study plan is structured to ensure a basic knowledge of all the main areas of philosophy; therefore, if you follow the rules of the plan, all disciplinary areas will be covered.

What are free credits?

The study plan includes 18 free credits for courses freely chosen among any undergraduate courses ("laurea triennale") offered by the university. Free credits can be used to take additional Philosophy exams or exams from any other course. Among the free credits, it is possible to repeat (iterate) a course. For example, you can use free credits to deepen the subject area of your thesis.

Which exams can be included among the free credits?

Any course belonging to a bachelor's degree ("laurea triennale") at the university can be included. These are identified by a class code starting with L-. Courses belonging to master's degrees (LM-)

or single-cycle degrees cannot be included. For example, you cannot include courses from the single-cycle Law degree, but you can include courses from the three-year Sciences of Legal Services degree.

Can I include first- and second-year Philosophy courses among the free credits?

Yes.

Can I include in the free credits a course open to students enrolled in later years than mine?

Yes, that's allowed.

Can I include in the free credits a course activated after my year of enrollment?

Yes, that's allowed.

I want to include a course activated after my year of enrollment, but the system doesn't allow me to. What should I do?

If, for any reason, you cannot add some exams online, you must still complete the online plan by selecting a different course (any exam will do, as long as you reach the required credits) and then confirm the plan. Once the plan is confirmed, contact InformaStudenti by **October 15, 2025** through the section "Your career" / "Study plan", writing "Online plan variation" in the subject line, and specify which exams should be replaced.

Can I earn more ECTS than required in the study plan?

Yes, it is possible to earn more than 180 ECTS. Extra credits are considered outside the plan and are not counted in the grade average.

What are extra-plan ECTS?

You can take exams beyond the required 180 ECTS. These will appear in your university record but will not count toward your final grade average. Extra-plan ECTS can be useful, for example, to obtain the necessary credits for teaching qualification classes or for admission to master's degrees in a different field.

Is there a limit to extra-plan ECTS?

No, there is no limit.

Can I take an exam and record it in the plan under the name of a similar course or one from the same disciplinary area?

No, courses are not interchangeable.

I obtained a validation for some ECTS from a previous academic career. How do I fill out the study plan?

You can include the validated exams in the online study plan.

I obtained a validation for some ECTS from a previous academic career, but I can't insert them online. What should I do?

If, for any reason, you cannot add some exams online, you must still complete the online plan by selecting a different course (any exam will do, as long as you reach the required credits) and then confirm the plan. Once the plan is confirmed, contact InformaStudenti by **October 15, 2025** through "Your career" / "Study plan", writing "Online plan variation" in the subject line, and specify which exams should be replaced.

What is an individual study plan?

An individual study plan is completed only in exceptional cases, such as:

- Exams taken at other institutions or degree programs (e.g., second degrees or previous studies) recognized by the university through an official resolution but not insertable online;
- Exams taken abroad under the Erasmus program that are not listed among the university's available courses;

- Scientific reasons (e.g., additional studies required for the thesis). If the 18 free credits have already been used, it is possible to request a modification to a course within a rule for valid scientific reasons. This is very rare and requires approval by the Academic Board. Approval is not guaranteed, so this path is discouraged.

How do I submit an individual study plan?

You must still fill out the online plan, selecting a different course (any exam will do, as long as you reach the required credits) and confirm it. Once confirmed, contact InformaStudenti by **October 15, 2025** through “Your career” / “Study plan”, writing “Online plan variation” in the subject line, and indicate which exams should be replaced.

Is it possible to repeat (iterate) exams?

Iteration means including the same course twice in your study plan. You can only repeat a course within the 18 free credits. This allows you to deepen your study of a subject, for instance, for thesis preparation. To repeat a course, you must contact the lecturer and agree on a specific program for the repeated version. You cannot repeat the same course more than once. It is possible to repeat two or three different courses within the 18 free credits.

“Iteration” means repeating a course with the same title; repeating a course from the same disciplinary area but with a different title does not count as iteration. For example, repeating the course “Theoretical Philosophy” (M-FIL/01) counts as an iteration if it appears twice in the plan, but taking “Theoretical Philosophy” and “Epistemology,” both belonging to M-FIL/01, does **not** count as iteration.

Can I repeat any course?

You can repeat any course; however, you must contact the lecturer to agree on an alternative program. The only courses that cannot be repeated are computer skills tests, English B1 courses, and workshops.

Can exams from the master’s degree be taken during the bachelor’s program and vice versa?

During the bachelor’s degree it is not possible to take any exams from master’s degree programs or single-cycle degree programs. During the master’s degree it is possible to take exams from the bachelor’s degree. It is possible to search for the courses activated for bachelor’s degree programs here: <https://www.unimi.it/en/education/degree-programme-courses/degree-courses-2025-2026>

Courses whose class code begins with L- may be included, whereas courses whose class code begins with LM- or LMG (single-cycle degrees) may not be included. For example, exams from the Law degree program cannot be included in the study plan because it is a single-cycle program, whereas it is possible to include courses from the three-year Sciences of Legal Services degree program.

Can a 9-ECTS exam be taken within a 6-ECTS rule and the remaining 3 ECTS used for “other educational activities” instead of a workshop?

No, this is not possible. “Other educational activities” are “other,” and the ECTS of taught courses cannot be used to cover them.

Can 3 ECTS be added to an exam already taken for 6 ECTS so that it fits within a 9-ECTS rule?

No, this cannot be done. Any exam already completed can no longer be modified. Moreover, 3-ECTS exams are not permitted.

Can an exam already completed for 9 ECTS be entered under a 6-ECTS rule and the remaining 3 ECTS placed among the free-choice credits?

It is possible, but this solution is not advisable because it may create problems in composing the study plan. It is preferable to place the 3 ECTS among the extra-plan credits and follow the regular compilation of the study plan.

Can exams from the new curriculum be taken?

No, this is not possible. However, it is possible to include exams from the new curriculum among the free-choice credits, and it is possible to include courses which have correspondences with ones of the new curriculum. If for some reason it is not possible to enter certain exams in the online plan, you must still complete the online plan by inserting in the relevant section a different course or courses (you may select any exam, with the sole caveat of still reaching the required ECTS) and then complete the procedure by confirming the plan. Once the online plan has been confirmed, you must contact InformaStudenti by **15 October 2025** via the section "Your career" / "Study plan," indicating in the subject line "Online plan variation" and specifying which exams indicated in the study plan must be replaced.

Is it possible to include, among the free-choice credits, a course from an inter-university program?

This is possible only if the course is offered by Unimi.

What are "Other educational activities"?

Among the credits for "other educational activities" are included workshops, internships, and additional language skills.

How is the "Other educational activities" entry completed?

It is completed by entering free text, with the name of the activity carried out (specifically, the title of the workshop) or a generic text. For example: "Workshop: Developing Skills for the Human Resources Management," 3 ECTS; "Computer Science course," 3 ECTS; "Workshop: Experimental Philosophy Lab", 3 ECTS; "High-level seminars and cultural initiatives," 3 ECTS. Otherwise, you can indicate generic text, for example: "Workshop 1," 3 ECTS; "Workshop 2," 3 ECTS; "Computer Science course," 3 ECTS.

Is it mandatory to include the Computer Science course among the "Other educational activities"?

Students enrolled starting from the a.y. 2020/21 must necessarily include the Computer Science course among the "Other educational activities." Students enrolled in previous years may choose not to include it. However, it is advisable to acquire the 3 ECTS for the Computer Science course, since most universities in Europe have included 3 ECTS for Computer Science course and 3 ECTS for the English Assessment – level B1 in all first-level degrees (as is the case in the new Philosophy curriculum). For the purposes of recognition in a foreign country of the degree obtained in Italy, the foreign university or institution could note the lack of these competencies. In addition, there are master's degree programs that might require ECTS in Computer Science as an admission requirement.

How many workshop must be taken?

Three "Other educational activities" of 3 ECTS, of which 2 workshops (or substitute activities) and Computer Science course (this is not mandatory for those enrolled before 2020/21, but it is strongly recommended).

Can I include courses offered for other degree programs?

It is possible to include courses offered for other degree programs among the free-choice credits.

SUBSEQUENT YEARS, ITERATIONS, AND EXAMS NO LONGER OFFERED

What should I do if a course listed in the educational plan for my year of enrollment is no longer active in my second or third year of enrollment?

It may happen that a course present in the study plan ceases to be active for various reasons. In this case, the exam may be included in the study plan only if it has already been taken.

An exam that I have already taken is no longer active. How can I include it in the study plan?

If an exam is no longer active but has already been taken, it can be included in the study plan.

I have already compiled the study plan, and this year an exam I had included is not being offered. What can I do?

Unfortunately, for various reasons (e.g., unavailability of lecturer in the scientific disciplinary sector), elective exams may not be offered. In such cases, you must change the study plan to insert an alternative exam, or verify whether there is a correspondence with another course (for further information, see the next answer).

In the year I enrolled there were exams available that are no longer offered. What should I do?

You must consult the Correspondence Table of Courses, available on the Philosophy program website on the page "Study" / "Study plan submission" <https://filosofia.cdl.unimi.it/en/study/study-plan-submission>. If the course originally entered in your study plan has a correspondence with another course, it is not necessary to modify your study plan. You may attend the classes and take the exam of the currently active course, which will then be recorded with the name of the course originally included in your study plan. If no cross-listing is active, you will need to modify the study plan.

If the course has not changed name but is listed as open only to students enrolled from later years than your own, a cross-listing is automatically active and it is therefore possible to take it.

I have already compiled the study plan and this year a course I had included under a 9-ECTS rule is offered as a 6-ECTS course in another rule. What can I do?

The exam can be taken only for 6 ECTS within the rule in which it is present. It is therefore necessary to revise the study plan by inserting another exam in the 9-ECTS rule and modifying the exams in the rule where the course can be entered for 6 ECTS.

I mistakenly took an exam that in the study plan was listed for 9 ECTS, but I took it for 6 ECTS. What can I do?

In the case of errors of this kind, there are two possibilities: you can modify the study plan during the opening window and move the mistakenly taken exam into a 6-ECTS rule, or you can ask the lecturer for a 6-ECTS iteration, of which 3 will compensate for the missing ECTS, while the other 3 may be included among the free-choice credits or among the extra-plan credits.

I have already taken the exam for a course that in the meantime has changed name. If I want to repeat it, what should I indicate in the study plan?

You must indicate the name of the course that you have already taken.

I would like to repeat an exam that I took for 9 ECTS, but I would like to repeat it for 6 ECTS; can I do this?

Yes, it is possible to include among the free-choice credits a 6-ECTS exam as an iteration of a 9-ECTS exam. If you encounter difficulties entering it in the online plan, you must still complete the online plan by inserting in the relevant section a different course or courses (you may select any exam, with the sole caveat of still reaching the required ECTS) and then complete the procedure by confirming the plan. Once the online plan has been confirmed, you must contact InformaStudenti by **15 October 2025** via the section "Your career" / "Study plan," indicating in the subject line "Online plan variation" and specifying which exams indicated in the study plan must be replaced.

In my year of enrollment, a course was listed that this year is no longer offered for Philosophy but is offered for other degree programs. May I still take the exam?

Yes, since the course was listed in your year of enrollment, it is possible to take the exam even if it is no longer offered for Philosophy.

I would like to replace an exam that is no longer offered, but I cannot find exams addressed to the old curriculum. What should I do?

If an exam is no longer offered, it must be replaced with another exam within the same rule. If you find courses intended for students enrolled from years later than your own year of enrollment, you

can still include these courses in the plan, since the exam from the old curriculum has a correspondence with the newly activated one. If you encounter difficulties registering for the exam call, you must contact the tutors. It is advisable to register for exams as soon as possible in order to have the time needed to resolve any problems.

I would like to take an exam present in my study plan that has kept the same title but is addressed to the new curriculum. What should I do?

It is possible to do so, since this is a cross-listing. If you encounter difficulties registering for the exam call, you must contact the tutors. It is advisable to register for exam calls as soon as possible in order to have the time needed to resolve any problems.

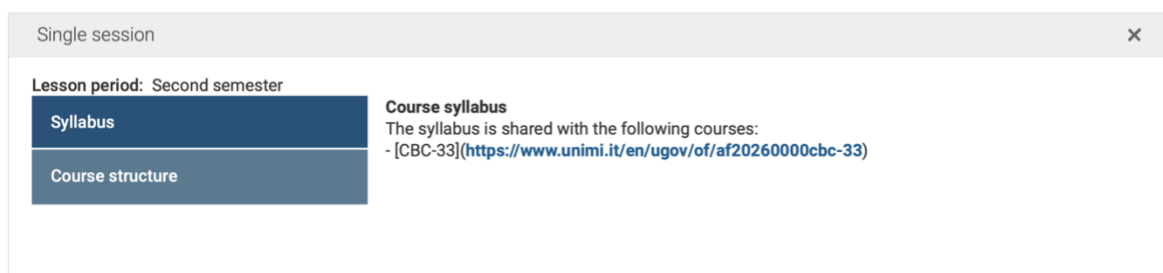
If exams from the new curriculum cannot be chosen, why, if I want to take “History of Political Philosophy” from the old curriculum, does the website redirect me to “History of Political Philosophy” from the new curriculum?

This is a cross-listing. Cross-listings are put in place when it is no longer possible to offer a course for the old curriculum and therefore, in order to provide adequate educational continuity, a cross-listing is created between the exam of the new curriculum and the equivalent exam of the old curriculum.

How can one tell if there is a correspondence with an active course?

It is possible to verify if there is a correspondence when, upon entering the syllabus of the course from the old curriculum, the statement “The syllabus is shared with the following courses” appears. For example:

What should be done in the case of correspondences?

In the study plan, the exam from the old curriculum is maintained, and students must register for exam sessions under the name that appears in their study plan. For example:

“History of Moral Philosophy” corresponds now to “Foundations of Ethics L–Z.” Therefore:

- “History of Moral Philosophy” is maintained in the study plan.
- You register for the exam under “History of Moral Philosophy.”
- If you wish to attend lectures, you will refer to “Foundations of Ethics L–Z.”

I want to register for the exam of a course which has a correspondence with an other one, but I cannot find it under the name that appears in my study plan. What should I do?

You must contact InformaStudenti as soon as possible to request activation of the exam. Since the procedure takes some time, it is preferable to make contact as early as possible.

Where can I find the correspondence between courses from the old and new curricula?

ERASMUS

I will go on Erasmus, but the host university has not yet published the list of courses. How can I complete my study plan?

Students who will go on Erasmus in the semesters following the compilation of their study plan must complete the plan through Unimi during the designated window, and upon returning from Erasmus they will complete the individual plan with the Erasmus coordinators, replacing the exams with those actually taken at the host university. Compilation does not necessarily have to take place during the modification window. It is recommended to compile the learning agreement immediately with reference to the study plan, since there must be full correspondence between the exams taken abroad and those recognized in the study plan.

I have returned from Erasmus. How do I know where to include the credits earned abroad in the study plan?

The learning agreement indicates the rule in which each of the exams taken should be inserted.

I will go on Erasmus. Which courses should I indicate in the study plan?

CREDITS FOR TEACHING QUALIFICATION

I would like to obtain credits for teaching in secondary school. Which courses should I include?

In the section “Careers and stakeholder” on the degree program website, there is a guide explaining the current regulations: <https://filosofia.cdl.unimi.it/it/il-corso/prospettive-e-stakeholder>. The guide provides some examples of exams to include in the study plan for teaching purposes. Teaching credits may also be acquired during the master’s degree program. It is preferable to divide the acquisition of the required credits between the bachelor’s and master’s degrees.

I need 12 ECTS for teaching. Can I take a 12-ECTS exam?

No, our educational regulations do not provide for 12-ECTS exams. It is suggested to take one 6-ECTS exam within a rule and another 6-ECTS exam among the free-choice credits. For example, to earn 12 ECTS in the disciplinary sector M-STO/02, you can include in Rule A1 the “Modern History” exam for 6 ECTS and include among the free-choice credits another 6-ECTS course within the same disciplinary sector, such as “Research Methodology in History,” or iterate the “Modern History” exam.

Do extra-plan credits count toward teaching qualifications?

Yes, credits exceeding the study plan count toward accumulating the required number of credits in each of the disciplinary sectors indicated for the teaching qualification class.

What are the “24 ECTS credits”?

The so-called “24 ECTS credits” are no longer required, as they have been replaced by a new pathway.
